### Full membership *(Membership runs over the financial year).*

Open to herbalists and naturopaths who have met our training requirements. Benefits include the quarterly *Australian Journal of Herbal and Naturopathic Medicine*; annual TGA Advertising Exemption Certificate; the ability to obtain professional indemnity insurance; the right to supply GST free consultations; use of the Association's name, initials and logo; full Association voting rights; the right to stand for nomination to the NHAA Board of Directors; regular information updates; full member access to the NHAA website and forums; and discounts to NHAA events.

### Australian Journal of Herbal & Naturopathic Medicine

Membership includes access to the AJHNM via our website. Hardcopy of the AJHNM is also available but will incur an extra charge of \$60. Please indicate in the payment section if you would also like a hardcopy.

**Fees** Full membership is \$315.00 for 2021/2022 within Australia (inc. GST) or \$284 International (ex. GST). Our membership runs on the financial year (see membership rates table on page 3). We have pro-rata rates available depending on which month you join.

**NB: Clause 2 applications incur a one-off additional processing fee of \$70.**

### CHECKLIST: what to include with your application

**QUALIFICATION CERTIFICATES and TRANSCRIPTS (Certified Copies).**

Interim membership can apply if you have not yet received your qualification certificate/s but are able to supply either a letter of completion from your institution and transcripts that **clearly indicate that you have graduated**. You are required to supply full documentation once received. **These must all be certified.**

**CURRENT PHOTO IDENTIFICATION (certified copy).** Such as passport or driver's licence.

NB: Certified Copies Are Required. We cannot process your membership until we receive these. SCAN and EMAIL your application with the actual copies written on by the certifier.

**INSURANCE AND FIRST AID INFORMATION** (practising full membership only).

- **NOT required for joining.** You can forward later, but you will not be listed as practising until they are received.
- NB. Minimum insurance requirements for practising members is \$2m professional indemnity and \$10m liability cover.
- A full First Aid course needs to be completed every 3 years to maintain a practising membership

**CONTINUING PROFESSIONAL DEVELOPMENT (CPD)**

**Required only if:** your qualification is older than 12 months **OR** you are re-joining and have a gap in your CPD.

- You must provide a CPD diary **and** evidence of 30 hours of CPD acquired within the last 12 months.
